QUALITY & CONSISTENCY ARE A TEAM EFFORT

A lot has happened since my last article in Woodv's World. Most notable is four months of unprecedented sales. I think we all know that, in June, we pushed out record sales. Then we followed that up in July with the third highest sales in company history, followed closely by August with our fourth highest sales month. I do not have final sales numbers for September yet, but I'm pretty sure September was also in our top ten and may even rank as the fifth highest sales month in company history.

With the hectic sales volume through the summer months, we are now within about 14% of last year's sales. However, keep in mind that last October was a record sales month for us, so by the end of this month, our margin of increase over 2015 will drop back down to about 12-13%—but that is still far more than we anticipated. Also,

much to my surprise, our export sales continue to grow at a very robust rate. Right now exports make up about 37% of our sales for the year. This is up from about 32% of our sales last year at this time.

What was accomplished these past four months is truly remarkable

I expect that we will have decent sales in the last quarter of 2016 (it is hard to believe we are already into the last quarter of the year) but nothing like what we experienced in the third quarter. For the past two years, November has been our slowest sales month of the year. I

wouldn't be surprised if either November or December are our slowest sales month for this year. However, if the sales pattern of the past couple of years carries through to next year, we will see sales start to ramp back up in the spring.

While talking about unprecedented sales, I also have to point out another unprecedented event, which is the way so many people stepped up in so many different ways to make it possible for us to get through the busiest time in our company's history, without falling behind. To make it even more amazing, many of our lead times are actually shorter now than they were at the end of May. When I talk to people from other companies and tell them what you guys did, I always get this look like they think I'm exaggerating. What was accomplished these past four months is truly remarkable


women learn to ride. Devienne enjoys travel, especially by bike, and looks forward to planning a cross country trip within the next few summers.

DAYLIGHT SAVINGS TIME THIS

Map of the Week: Daylight Saving Time (DST)



You know folks, it's time to get real. They're going to make us mess with time again. Anyone who has watched a sci-fi flick knows that time can neither be created nor destroyed by ordinary means, and messing with time usually ends very badly. So let's have a little discussion about this whole daylight savings thing.

The name implies that time saves daylight. I don't know about you, but I want to know what bank they keep all that extra daylight in. And does it pay interest, like 5% more minutes of light for each hour deposited? And where is the vault that they keep all this extra daylight in? Is it next to all the gold that is allegedly in Fort Knox? And if you tap into this daylight bank, are you living on borrowed time?

Daylight Savings Time (DST) was proposed in 1895 by some guy in New Zealand that wanted an extra hour of daylight after work to collect bugs. It was first put into practice in Canada. Everyone knows that, if Canada and New Zealand are on board with daylight savings time, the U.S. should be right there, and right there we were in 1918 because, like President Obama, Woodrow Wilson really liked to play golf.

You see, DST was instituted twice in the U.S.-during each World War. It never really caught on during peace time and was vehemently opposed by the agriculture industry in America. The farmers didn't like it much, citing the fact that the extra hour of daylight burned up the crops. The U.S. standardized DST in 1966, under the auspice that states could "opt out" if they were so inclined. DST was rationalized during the 1970's under the guise of saving resources during the energy crisis. And, in 1988, an extension for DST passed through Congress, with the Senators from Idaho citing that during Daylight Savings Time fast food restaurants sold more french fries.

You know, objectively, DST probably did save resources in the 1970's. But back then not as many people had air conditioning as do now. I think the savings went out the window with the extra hour each day that the average American now has to air condition their home in the summer. Perhaps the only people who do benefit are bar owners. When we switch from DST back to Standard Time in the fall, that extra hour of staying open makes them lots of money

on booze sales. But just think of how much energy those bars expend in lights and heat staying open that extra hour. There are roughly 66,000 bars in the U.S. That constitutes a lot of hours of energy, and some may have to borrow from the sunlight bank just to stay open that extra hour, depleting our stores in Fort Knox and throwing our country deeper into debt.

Seventy-five percent of the world either has never tried Daylight Savings Time, or has tried it and abandoned it. I'm talking 1.5 billion people in China, 1.6 billion people in India, almost all of Africa and South America, 3/4ths of Australia, and virtually all of Russia that do not participate in fooling themselves into thinking that there is an extra hour of sunlight during the summer. I mean look, even Antarctica tried DST and gave it up. What with global warming and all they didn't want that extra hour of sunlight melting still more ice, and evidently it really confused the penguins and disrupted their mating habits.

As you may have guessed, I'm not really a fan of the whole "change the clocks 2 times a year" club. I'm

while I hold the SET button, and then it messes up the alarm and I have to spend another hour figuring out how to reset that whole thing....truly a pain!) But let's say the average person just spends 10 minutes wrasslin' with the clock deal. That's roughly 2 billion people times 10 minutes times twice a year. That translates into approximately 666,666,666,666.666 man hours

wasted on just spinning the hands on a clock annually. With that kind of labor power, each year

GLASSTECH DUSSELDORF

September 20-23 the biggest glass tradeshow in the world, Glasstec, took place in Düsseldorf Germany. This show normally takes place every other year, and is normally held towards the end of October or early November. This year the dates were moved to September due to a conflict with another show held in the same exhibition

with the plan to incorporate it on several lifters starting in January. Intelli-Grip is the name given to our innovative technology that controls the response of the lifter based on self-diagnosis of the lifter, vacuum levels that are monitored throughout the operational cycle, advanced battery and power system feedback, and other system information.

The vacuum system monitoring allows the system to respond in various ways to changing vacuum level for safety reasons. One of the

most useful and unique benefits is that it quickly performs a vacuum system leak test to ensure that every attachment to every load has a secure seal. Additionally if a

vacuum level is detected while the lifter is not in the attach mode, the pump will a load if it is determined that the battery energy level is too low to safely proceed.



attempt to fully attach. This avoids

kick on and

accidentally lifting a load with an unsafe vacuum level such as might occur with an incomplete load release. There are also additional safeguards to avoid accidentally turning the machine off when attached to a load.

The power system monitoring has become much more thorough in that it evaluates both the need to charge the battery and whether it needs replaced. The most noticeable change with the monitoring of the power system is that the lifter will not attach to

To assist in introducing this technology several of us attended the show to help explain it. Both Bohle and CRL made space for us in their booths and allowed us to work alongside them. We took turns going from one booth to the other to demonstrate the technology. We also took some time to walk the show as this is one of the best opportunities to see what is new and popular in the glass industry. The show was also a good opportunity for me (Barry) to have a few meetings to foster dealer and customer relations.

Overall it seemed to be a very busy show. Word was that it was not as good as it was two years ago, but there was never a point that we were standing around bored.

A PIECE OF HISTORY AT WPG

Inthe year 1955, the United States announced a plan to develop intercontinental ballistic missiles; rockets able to deliver nuclear warheads across the globe. That same year, the Warsaw Pact was signed as the Soviet reply to

NATO, Bill Gates and Steve Jobs were born, and the Vietnam War began. 1955 was also the manufacture date for a Hardinge lathe used on the Wood's Powr-Grip production floor.

Purchased as military surplus, this lathe was originally used at the Naval Ordnance Plant in Indianapolis. The ordnance plant was commissioned in 1942, completed in '43, and was used to manufacture the famous Norden

bombsight, as well as gunnery fire control systems.

Although vital to the war effort and a fiercely-guarded secret, the Nazis were able to steal the technology before hostilities broke out as part of an infamous spy ring. The Germans used

the information to help manufacture the "Lotfe 7" bombsight, which was used on the world's first jetpowered bomber late in the war.

After the end of World

War 2, tensions continued to grow between Communist nations and the US-led democracies. The tension eventually erupted into the Korean War, when a Chinese and Soviet-backed North Korea invaded the South. In this proxy war, the Norden bombsight

WHAT ARE SAFETY DATA SHEETS (SDSS)?

Safety Data Sheets are written or printed materials with information about hazardous chemicals. These documents are provided by the manufacturer or importer of the chemical. They include what chemicals are in a product, the physical and health hazards of those chemicals and what steps must be taken to prevent adverse effects when using the product.

Safety Data Sheets and the Hazard Communication Standard:

The Hazard Communication Standard requires a written hazard communication program to be in place. This written program requires:

- SDSs to be obtained and accessible for all chemicals used in the workplace.
- A chemical inventory list.
- Training for all employees to assure they know:
- How to read and understand the SDSs.
- The health and physical hazards of the materials they could be exposed to.
- The proper controls to safely handle the chemicals used.

The contents of a SDS:

When a chemical manufacturer or importer prepares a SDS, it must have 16 headings or sections as outlined below. These sections correspond with the international requirements established by the Globally Harmonized System of Classification and Labeling of Chemicals (GHS). The standardized format provides uniformity around the world.

Listed are the 16 sections with a brief description of what is required in each section: Section 1: Identification
 Product identifier,
 recommended use, restrictions of use and contact information of the manufacturer.

Section 2: Hazard identification

Pictograms, hazard statements, signal words and precautionary statements.

 Section 3: Composition Ingredients, chemical name, common name, and Chemical Abstract System (CAS) number.

Always refer to the applicable Safety Data Sheet when using chemicals.

It can keep you and your co-workers safe.



• Section 4: First aid measures

Description of necessary measures specific to the method of exposure.

- Section 5:
 Fire fighting measures
 Suitable extinguishing media specific to hazards arising from the chemicals.
- Section 6: Accidental release measures

Personal precautions to take, Personal Protective Equipment (PPE), containment and cleanup procedures.

Section 7: Handling and storage

Precautions for safe handling.

Section 8: Exposure controls

Permissible exposure limits (PEL) and appropriate engineering controls.

Section 9: Physical and chemical properties

Includes but is not limited to appearance, odor, melting point, pH and flash point.

Section 10: Stability and reactivity

Reactivity, chemical stability and conditions to avoid.

Section 11: Toxicological information

Health effects, information on routes of exposure, symptoms related to chemical, physical and toxicological characteristics.

Section 12: Ecological information

Degradability and bioaccumulative potential.

- Section 13: Disposal considerations
 Safe handling of waste residue.
- Section 14: Transport information

Proper shipping name and transport hazards.

• Section 15: Regulatory information

Safety, health and environmental regulations.

Section 16: Other information

Date of preparation and date of last revision.

DECEMBER IS OPEN ENROLLMENT MONTH INSURANCE IN 2017

Just like in all the years past, December is the open enrollment period for insurance coverage changes in insurance coverage. Because we have a lot to accomplish in a short time, this is a very busy time of year that requires a lot of cooperation by everyone to get everything done.

At some point in late October or early November, Flexible Spending Account Forms for 2017 will be available from the HR Department. It is on this form, if you are eligible, that you elect and designate the following things:

- ✓ Health Insurance participation in coverage for 2017?
- ✓ Flexible Spending Account Contributions - Medical
- ✓ Flexible Spending Account Contributions -Dependent Care
- ✓ Optional Life Insurance
- ✓ Optional Dental Insurance
- ✓ Optional Vision Insurance

The deadline for completing and returning these forms and all other additional documentation to HR has not yet been set, but will likely be Monday, December 5, 2016, so that the forms can be given to EBMS and PayneWest Insurance so they can get everything organized and in place by January 1, 2017. I realize that it doesn't give each of us much time to get things done, but it is the nature of the beast at this time of year.

As most of you already know, you can elect to have money taken out of each of your paychecks, pre-tax, and put into a Flexible Spending Account (FLEX account or FSA). There are actually two separate parts of a FLEX account. There is the Health Flexible Spending Account. Unless the government changes the limit again this year, the maximum amount you can put in this account is \$2500. Money in this account can be used to pay medical expenses that are not covered by insurance - glasses, dental expenses, etc. There is a list in the break room of what flex money can be used for. By using "pre-tax" dollars, in the end you actually save some money that you would have otherwise spent if

account is the Dependent Care Assistance Plan. Unless the government changes the limit again this year, the maximum amount you can put in this part of the account is \$5000. Money in this account can be used to pay day care expenses for your children while you are working. Again, by using "pre-tax" dollars, in the end you actually save some money that you would have otherwise spent if you had no

As in the past, for each employee, who would normally be eligible to participate in the health insurance plan, but chooses not to participate, over the course of 2017 the company will deposit money into a FLEX account for that employee. As like this past year, because of past changes made in federal law by the Affordable Care Act, the limit of the amount that WPG can put into a FLEX account under these circumstances is \$500. For employees who choose not to participate in any of these programs or who are otherwise not eligible, you will still need to sign a FLEX form declining participation.

They are going to provide a 6 yard container on our West side of the building. I will purchase additional All-In-One recycling containers and place them in the areas of the shop that



were recognized during the audit. As we begin this program please feel free to request additional containers or let us know how to improve the program.

The main goal of this program increase our recycling efforts, and reduce our overall waste costs with the city containers.



All-In-One Recycling We sort so you don't have to!

The following information should answer any questions regarding our service. Please contact our office should you ever have any additional questions or concerns regarding your account or our services.

You may place the following items in your recycling container:

Plastic

Any plastics marked 1-7 with the universal recycling symbol. This would include water bottles, yogurt containers, butter dishes, to-go clam shells, and detergent bottles. If they contained food or liquid, a quick rinse to remove most all of the left-overs is all it takes. Leave the labels on.

Aluminum

Any kind of aluminum cans, bottles or foil is acceptable, as long as it is emptied and free from food.

Tin/Metal

All of your tin cans, metal containers, scrap metal up to 16 inches can be diverted. Again, make sure it is free from left-over food and not covered in oil and it can be recycled. Leave the labels on.

Paper

The new rule is, if it looks like paper and it tears . .It is paper so recycle it This includes newspaper, magazines, junk mail, homework, and books. The only exception is foiled wrapping paper.

Cardboard

Again, if it looks like cardboard and it tears .. it is cardboard. So put your cereal boxes, your cardboard egg cartons, and your Amazon boxes in the cart. Flatten your boxes to get the most room in your cart.

Grocery Bags

We can recycle these but ask that you put all your bags inside one bag and tie it up before putting it in the cart as it is hard on our sorting machines. This includes shrink wrap!
